A general meeting of the Sewer Authority of the Borough of Minersville was held Wednesday, March 28, 2018 in Council Chambers, North Delaware Avenue and East Carbon Street. Chairman Thomas Eltringham opened the meeting with the flag ceremony at 7:00PM.

ATTENDANCE

The following members attended the March meeting- Jeremy Olenick, Santino Angelo, Thomas Eltringham, Rich DiBiase, Albert Bobinas and Borough Manager Robert Mahalchick. Councilmen Steve Darosh and Robert Umbenhen.

MINUTES

Mr. Bobinas made a motion to approve the February 2018 minutes. On the question, the bid from A.H/Moyer, Inc. should read-\$50,095.00. With that correction, Mr. Angelo seconded the motion. The motion passed as presented.

FINANCIAL REPORT

Mr. Angelo made a motion to approve the February Financial Report. On the question, Mr. Mahalchick stated a transfer was made from the Reserve Account to cover the Sewer Checking account. Mr. Olenick seconded the motion. The motion passed as presented.

ENGINEER'S REPORT

The Engineer was not present at March 2018 meeting. Mr. Angelo made a motion, second by Mr. DiBiase to sign the prepared 2017 Chapter 94 Waste load Management Report for submission. The motion passed as presented. The Street and Sewer workers will be doing the excavating for the TV and Cleaning Project. Mr. Angelo instructed Mr. Sukeena to flush manholes with a fire hose when they are uncovered so the cameras can fir thru. Mr. Eltringham reminded Mr. Mahalchick to be sure the Borough Council gets a spreadsheet on the expenses associated with the project.

SEWER OPERATOR'S REPORT

Ray Sukeena presented Authority members with a written report. Mr. Sukeena reported finding a motor for the garage door at a cost of \$196.00. Mr. Bobinas respectfully requested that requests to be exonerated from Sewer Bills due to broken pipes, be examined on a case-by-case basis.

SOLICITOR'S REPORT

The Solicitor was not present at the February meeting, but has cut his retainer in half. Mr. Pellish is in constant contact with Mr. Mahalchick.

UNFINISHED BUSINESS

Mr. Mahalchick reported he is still shopping for a cell phone for the Sewage Treatment Plant worker-on-call.

OLD BUSINESS

Mr. Sukeena reported that a grinder pump, installed privately by a contractor hired by the homeowner on Teaberry Hill Road, is the homeowner's responsibility for upkeep.

CORRESPONDENCE

A thank you note was received from the Mason family on the passing of Pat Mason, a long time Borough employee.

NEW BUSINESS

Mr. DiBiase made a motion, second by Mr. Angelo to recover Minersville Sewer Authority Unclaimed Property as advertised by the state. The motion passed as presented.

The April 25, 2018 meeting will be held at the Sewer Treatment Plant.

Mr. Angelo made a motion to adjourn. Mr. DiBiase seconded the motion.
