

JUNE 23, 2021

A general meeting of the Sewer Authority of the Borough of Minersville was held Wednesday, June 23, 2021. Vice Chairman Jeremy Olenick opened the meeting with the flag ceremony at 7:00PM.

ATTENDANCE

The following members attended the June meeting- Jeremy Olenick, Al Bobinas, Jeff Enders-by telephone, Authority Engineer Don Cuff, Councilman Steve Darosh and Manager Bob Mahalchick.

MINUTES

Mr. Bobinas made a motion, second by Mr. Olenick to approve the minutes from May 2021. The motion passed as presented.

FINANCIAL REPORT

Mr. Bobinas made a motion to approve the May Treasurer's Report. Mr. Olenick seconded the motion. The motion passed as presented.

VISITORS

There were no visitors at the June 2021 meeting.

ENGINEER'S REPORT

Mr. Bobinas made a motion, second by Mr. Olenick to approve Application #2 in the amount of \$27,875.92. The motion passed as presented. Mr. Olenick made a motion, second by Mr. Bobinas to pass Application #5 in the amount of \$10,450.80. The motion passed as presented. Mr. Bobinas made a motion, second by Mr. Olenick to approve Requisition #7, which included both applications for a total amount of \$62,965.75 to be paid. The motion passed as presented. Don Cuff reported that no new projects would be started this year keeping money in reserve. Mr. Reber's pond continues to deteriorate. Mr. Cuff recommended going forward with limestone wells to help solve the problem.

SOLICITOR'S REPORT

The Solicitor was not present at the June meeting.

SEWER OPERATOR'S REPORT

Mr. Sukeena presented a written report to the Authority. Don Cuff reported that during excavation for the WAS line, the existing line was deteriorated and collapsed. Pipe was cast iron and from the 70's. Mr. Cuff reported that other pipe is being investigated for similar problems. The new level of pipe available now is guaranteed for 100 years. Mr. Olenick made a motion, second by Mr. Bobinas to purchase additional 4-inch pipe to have on hand. The motion passed as presented. Don Cuff estimates three or four hundred feet of pipe to have on hand but he will look into the amount.

A thank you note was received from Mr. Mahalchick's family on the passing of his father in law.
